



2026 Community West Gift of Life \$5,000 Grand Prize Raffle

Official Rules

The Community West Foundation ("Community West"), a tax-exempt 501(c)(3) organization is sponsoring a fundraising raffle (the "Raffle") in accordance with the laws of the State of Ohio. The Raffle shall be known as the 2026 Community West Gift of Life \$5,000 Cash Grand Prize Raffle ("the Raffle"). All proceeds of the Raffle will go to benefit Cleveland Clinic Fairview Hospital ("the hospital") and will be used in furtherance of the hospitals' charitable purposes. The rules and regulations of the Raffle are set forth below. By purchasing a raffle ticket ("Ticket"), the purchaser agrees to be bound by these rules and regulations. The interpretation and application of the rules and regulations by Community West and its legal counsel shall be final.

Eligibility:

The Raffle is open to all legal residents of the United States, who are 18 years of age or older as of the date of entry. All federal, state and local laws and regulations apply. Void in Colorado, New York and Florida and where prohibited by law.

To Enter:

Community West will sell Tickets online at CommunityWestFoundation.org. The odds of winning the Prize, as hereinafter defined, will depend on the final number of Tickets sold. Ticket sales will begin at noon (12:00 P.M.) April 1, 2026, and end at 9:00 P.M. on Tuesday, August 11, 2026. Winner will be pulled at the Gift of Life Event at the Cleveland Metroparks Zoo. Winner does not need to be present to win.

Per IRS rules, amounts paid for raffle tickets are not gifts to the charitable organization and do not qualify as deductible charitable contributions.

No refunds.

Prize:

The cash prize is \$5,000. Ticket prices are 1 for \$50 or 3 for \$100. Purchasers may purchase multiple tickets. No substitutes.

Community West Foundation will not withhold taxes, and the winner is responsible for reporting the winnings on their tax return. Community West assumes no responsibility for Winners' taxes and/or legal obligations and suggests Winners consult their tax and/or legal advisor. When required, Federal tax will be withheld and taxpayer information forwarded to the IRS in accordance with tax laws. Winners must provide Community West with all necessary information required for tax purposes prior to delivery of the prize. Failure to do so within ten (10) days of request shall result in an automatic forfeiture of such winner's prize.

Random Drawing:

The Prize drawing will be announced on Tuesday, August 11, 2026 at the Gift of Life event. One Ticket will be selected by Community West at random in accordance with Ohio laws. The first Ticket selected that meets the requirements as set forth in these Official Rules will win the Prize. The Prize will be awarded to the individual whose name appears on the Ticket (the "Winner"). Purchasers of the Ticket will not be deemed to be the Winner unless his/her name appears on the Ticket. **Only one name may be used on**

ticket. The Winner will be announced on the website after August 11, 2026. The Winner will be notified by the telephone number and/or email address listed on the Winner's entry form, or in person (if possible). The Prize/ check will be available for pick up starting on or after Friday, August 14, 2026 at Community West Foundation. Winners must claim prize within 2 weeks of notification.

Only one eligible person may be entered in the Raffle per Ticket sold. If the name of more than one person is submitted with a Ticket purchase or the Ticket contains incomplete information, or the Ticket is otherwise deemed noncompliant with the Official Rules then that Ticket will be deemed to be void and another Ticket will be drawn. Community West reserves the right to reject any Ticket purchase that is submitted with payment that does not constitute "good funds" or that is otherwise noncompliant with the Official Rules.

By entering the Raffle, the Winner agrees that his/her name and/or likeness may be disclosed to and used by the news media, Community West and/or the hospitals for promotional purposes without additional compensation. In addition, each participant releases the corporate entities of Community West, the hospitals and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the Raffle or winning the Prize, or resulting from acceptance, possession, use or misuse of the Prize. **The Winner of the Prize and/or their family, heirs, associates or other interested parties agree to indemnify and hold harmless the corporate entities of Community West, the hospitals, and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all losses, damages, rights, claims and actions of any kind arising in connection with or as a result of the Winner's acceptance or use of the Prize.**

A Raffle participant's sole and exclusive remedy for Community West's breach shall be limited to the return of the purchase price paid for his/ her Ticket(s). In no event shall the corporate entities of Community West, the hospitals and their respective directors, officers, employees, volunteers and agents be liable to any party for any loss or injuries to earnings, profits or goodwill, for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages by counsel.

By purchasing a Ticket and choosing to participate in the Raffle, each Raffle participant acknowledges and agrees that Community West has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason, and in such event, a participant's sole and exclusive remedy shall be to receive a refund of the full price paid by such participant for each Raffle ticket purchased, without interest.

The name and logo of Community West and Cleveland Fairview hospitals are registered trademarks, and no other person or entity is authorized to copy or otherwise use them without the express written consent of Community West, Fairview Hospital, and/or Cleveland Clinic.
